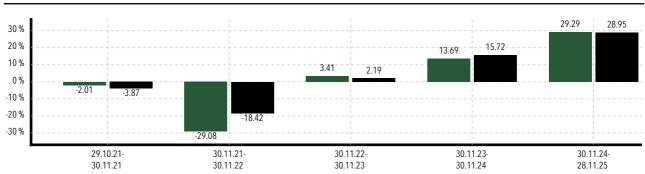






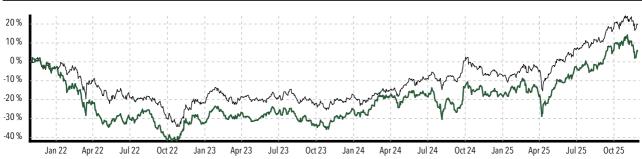

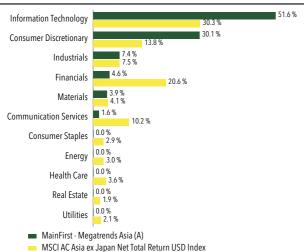

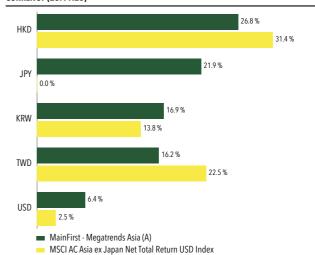

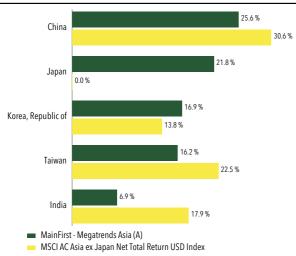
SECTOR ALLOCATION (28.11.25)4



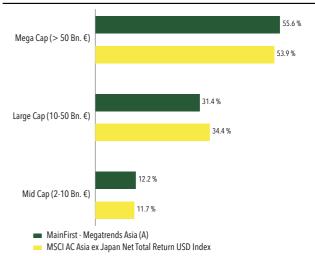
CURRENCY (28.11.25)4)
